An individual who has no affiliation with the organization, other than as an IRB member, is considered *unaffiliated*. At STANFORD, the organization consists of Stanford University, Stanford Hospital and Clinics, Lucile Packard Children's Hospital, VA Palo Alto Health Care System, or Palo Alto Institute for Research and Education, Inc.

For former employees, affiliation depends on whether the individual is receiving benefits from Stanford, and the length of their service at Stanford.

An individual whose only association with STANFORD is that of patient, research participant, or *former* student may be considered unaffiliated.

Paying an unaffiliated member a reasonable market value for his or her services does not cause the member to become "otherwise affiliated" or cause the member to have a conflicting interest.
